1. Objective

- a. Performs manual labor functions to construct and install fiber line system to bring high-speed internet to the membership.
- b. Troubleshoots connectivity issues and responds to outages to maintain connectivity and reliable internet service to membership.
- c. All above objectives are expected to be performed with the Cooperative's best interest in mind and in line with the Core Values.

2. Essential Job Functions

- a. Performs fiber operational function by working with internal and external crew members to construct fiber optic system, both overhead and underground.
- b. Installs fiber connection in buildings and homes
- c. Troubleshoots connectivity issues and makes repairs as needed to include splicing fiber lines, running line out, and working with electronics from time to time.
- d. Responds to outages and provides on-call, after-hour support to fiber members.
- e. Resolves member questions in-field and escalates issues through Fiber management and Member Services.
- f. Works with the warehouse to ensure accurate retrieval of construction and supplies for operations.

5. Job Specifications

- a. <u>Communication Skills</u> Must be able to convey complicated concepts in a simple and concise manner. Adequate presentation skills are a must.
- b. <u>Computer Skills</u> Must be able to use Microsoft Word, Excel, and Project, tablets, and have a good understanding of mobile and computer technology. Must be able to learn new software and technology.
- c. <u>Language Skills</u> Must have the ability to read, write and speak the English language.
- d. <u>Mathematical Skills</u> Must have the ability to work with mathematical concepts.
- e. <u>Other Skills</u> Must have the ability to understand and follow Cooperative maps, Cooperative Safety Manual, work orders, staking sheets, and any type of Cooperative forms related to work being performed. Must have the ability to learn cooperative's service area and distribution system. Must have the ability to learn and understand the installation of fiber systems.
- f. <u>Planning Skills</u> Must have the ability to plan for the current project's needs

- g. <u>Personal Characteristics</u> Work requires independent and original thinking. Must be a team player and be able to work independently. Must represent the Cooperative in a positive manner.
- h. <u>Reasoning Ability</u> Must have the ability to analyze situations and develop solutions to solve practical problems.
- i. <u>Physical Characteristics</u> Must be able to use hands, fingers, arms for grasping, reaching or holding items. Must possess general dexterity to operate a personal computer and small hand tools. Will be required to regularly sit and frequently stand and walk. Will be required to climb, balance, stoop, knell, crouch and crawl. Must be able to hear. Will be required to lift up to 75 pounds. Specific vision abilities include close, distance, color and peripheral vision. Must have depth perception and ability to adjust focus.
- j. <u>Working Conditions</u> Work mainly takes place in an outdoor environment which may lead to exposure to extreme heat and humidity as well as extreme cold. Will be exposed to moving mechanical parts; risk of electrical shock or vibration. Noise level is usually moderate. Will be required to drive company vehicle and work outdoors to oversee fiber system and project management.
- k. <u>Working Hours</u> Average work week consist of four (4) ten (10) hour days. Work regularly scheduled hours, although weekends, evenings and holidays may be required to meet deadlines or to attend meeting or conferences.
